We pleased to nominate Mike Garrett to the California Shuffleboard Association Hall of Fame.

Mike was introduced to the game of shuffleboard after moving to Hemet, and finding an outlet for his competitive spirit, shuffleboard became his passion. He started playing in 2014 and already placed in his first CSA Singles tournament in 2015. He is widely known in the western US shuffleboard circuit, due to his membership with a Western National Shuffleboard team that plays in Arizona, as well as his outside tournaments in Nevada and Utah. Mike is also an enthusiastic contributor on committees and boards, such as:

- CSA Soboba Classic Committee 2014 to present: responsible for awards, recruitment, and board dressing
- District 7 Board of Directors on special projects 2014-16
- District 7 Instructor. 2019 to present
- CSA Board, 3rd VP 2020 to present

Mike's dedication to the game is inspirational. Despite having a terrible accident resulting in long therapy with multiple operations, he eventually came back to the play. But this time with extra braces, ice packs, and heating pads to get through the pain. He has since continued to exhibit his expertise in this game, placing in 10 tournaments in 2019, and 8 in 2022! REPORT FROM SHIRLEY EAGER,
2ND VICE PRESIDENT
February 27, 2023

As 2nd Vice President of the USA National Shuffleboard Association, I am the Chairman of the Rules Committee. This year our committee has met via zoom and at the Semi Annual meeting in July we submitted to the Officers and member State Presidents & Delegates amendments to the Constitution and By-Laws relating to the playing rules and guidelines for all National Tournaments approved by the USA National Shuffleboard Association.

The current rules were not being followed so our committee was assigned the task of developing a set of playing rules that were consistent throughout the United States since Florida has its rules, Ohio has theirs, Texas has different rules. Arizona and California have their rules so you get the picture. After much discussion, the committee submitted for vote at our Annual meeting which was held January 30 an amendment as follows:

“The official playing rules of the State that hosts any type of National Tournament shall be followed, without exception. Each hosting state shall supply a copy of its official playing rules to the USA NSA President. Said official playing rules will be included on the USA National Shuffleboard Association website.”

So, if any of you are planning to play in a National Tournament in another State, you will be expected to play by the hosting State's rules which you'll be able to find on our USA – NSA website.

Other changes the Officers and member State Presidents & Delegates voted on are:

- 1. Not more than one National tournament will be scheduled within the same week unless it is at the same venue.**
- 2. Individual National Tournaments will be scheduled an adequate number of days apart to allow for travel for players who choose to participate in multiple tournaments.**
- 3. Clubs hosting National tournaments in consecutive years are expected to host the tournament in the same week of the year from year to year. Due to scheduling conflicts, the National Tournament Schedule shall take precedence.**
- 4. Proposed changes to the timeframe of the tournament must meet all the conditions of the USA National Shuffleboard Association Constitution & By-Laws and be submitted to the National President by April 30 prior to the Semi-Annual meeting. The change will be accepted or rejected by majority vote at the Semi-Annual meeting.**

All changes our committee proposed were approved by a vote of the Officers, State Presidents and Delegates.

I am now working on Constitution and By-Law changes to the Hall of Fame section and to allow for communication to be through mail, email or on our website.

Our President, Kathy Brennan, attended and participated in the National Doubles Tournament held here last April and she intends to return and play in the National Doubles Tournament here in Hemet next April. Her goal when she took office in January, 2022, was to attend and participate in every National Tournament which to date she has done.

The application for the 40th International Shuffleboard Association World Singles Championship in St. Petersburg, Florida, to be held October 22 – 27, 2023, has been posted on the USA NSA website. We have been asked to field a team of 20 men and 20 women from the United States. The deadline to submit an application is April 15. This tournament will be held on the historic courts in St. Pete. The St. Petersburg Shuffleboard Club was instrumental in establishing the rules that have become standards for the game. They have been hosting shuffleboard enthusiasts since 1924 and the first National championship was held there in 1931.

I have been asked to try to increase the number of National Tournaments west of the Mississippi with the possibility of making all of the California Shuffleboard State Tournaments National Tournaments. All notes, charts, drawings of boards either written or digital are prohibited once a player has entered the premises of a shuffleboard venue. The penalty is -10 points off the player's score.

We will need to remove all of the flags clean and restore them if possible. These flags were donated to CSA by Ruth and Roland Schneider. All the plaques will have to be removed and we may have to rent a storage unit to hold everything until a suitable location can be found. I prefer finding a public location maybe a room at the museum or a Hemet city location, where the public can have easy access. This is a big job and it surely will need a committee.

Last but not least I have been trying to kick around ideas to grow shuffleboard in California. If we don't do something this sport will die and it will be a shame if that happens. CSA meeting with Colleen Patterson: Regarding Hall of Fame damages and liability insurance.

During the rainy season of 2021, Golden Village Palms recreational shuffleboard building caused excessive rain damage to CSA Hall of Fame Records. We question **whether** Golden Village Palms could be held liable for the repair. Colleen stated that more than likely their insurance was written in such a manner that it did not cover third party property.

We also had some discussion about Liability Insurance for the officers of CSA. Colleen stated she checked into that issue when her father was president of CSA and after the large amount of monies received from the International Tournament held in Hemet CA., in or about 2002. As long as CSA maintains their records and requires two signatures on all checks we should be OK.

At the conclusion of our meeting I had already determined that's CSA could no longer afford to hold tournaments at Golden Village Palms if they were going to require us to provide \$1,000,000 liability insurance coverage to play tournaments there. Furthermore the management at Golden Village Palms stated sometime in the future they would be removing lanes in that building.

This brings up another important issue of always having at least two people at a meeting. You don't have any way of backing up what you've said or what they've said when it's a one-on-one meeting. It's not a good idea and another reason for committees.
